



Report on the 3rd USDA/FAEA-supported GOK task force retreat on food safety policy review and legislation drafting Enashipai Resort and Spa, Naivasha 28 September 2021-3 October 2021

Preamble: The legislative process on food safety has been on-going in earnest, since it was reignited in 2019, attaining steady progress since 2020, when FEAE gave support. In compliance with the requirements of policy and legislative process in Kenya, stakeholder consultations have been undertaken, including rigorous consultations in all the forty seven counties, with the exception of Lamu County. Several comments came through from the consultations, cutting across various sectors, expertise, and geographies.

The main objective of the third task force meeting was therefore to take stock of all the comments that came from stakeholders including those at the counties, and consider them for adoption into the draft food safety policy and bill.

Purpose of the meeting

- 1. To review all comments that came from stakeholder consultations and consider them for adoption into the draft food safety policy and bill.
- 2. To review and agree on the roadmap for the remaining steps to complete the foods safety legislative process.

Key observations during the retreat

The following are key observations made during the retreat:

- 1. There were several recommendations from consultations that focused on how to improve the bill. While they were diverse, they were not in conflict with the spirit of the bill.
- 2. There was tremendous improvement in the active participation of the inter-ministerial team. In particular, the health team participated actively and all decisions were arrived at by consensus.
- 3. The taskforce agreed to come up with an office of the food safety controller, that consolidates the oversight of food safety aspects in Kenya but leaves competent agencies with a defined mandate on food safety. Hence several agencies will still have a food safety mandate under the current proposal. Subsequently, the proposal to consolidate all food safety functions under one agency was discarded. The agencies with a food safety mandate are listed in the first schedule of the bill.
- 4. There was a proposal to introduce consequential amendments to deal with existing acts that may require to be reviewed in order to avoid duplicity and pave way for clear mandates.
- 5. The title of the bill was amended to read "Food Safety Control Coordination Bill 2021".
- 6. The issues on feed regulation were discussed at length. While majority of the stakeholders consulted at County and national level proposed its inclusion in the bill, the taskforce was split in the debate, with some members feeling that it should be included while others felt it should be left out. The matter was escalated to PS level to make a determination.
- 7. While it is now clear that the food safety law will be premised on scientific evidence and a risk based approach, there seemed to be lack of clarity as to why the law also proposed



inclusion of the precautionary principle. The proponent argued that there could be cases where scientific evidence may not be sufficient to make decisions, in which case the precautionary principle would kick in.

- 8. The issue of who would sign off the Policy and the bill and where the two instruments would reside, including where the office of the food safety controller would be, was not agreed upon by the taskforce, and the matters were recommended for escalation, to be determined at PS/CS level.
- 9. There was a smaller group of taskforce members who arrived earlier, on Tuesday morning, and they were joined by the rest of the taskforce members on Friday. Members had to work full day on Saturday in order to complete the two documents. Logistical arrangements went on smoothly. In spite of the tight timelines that we had to work under, we received wired funds in good time to be able to make all payments while still in Naivasha. The following table shows a summary expenditure report. Detailed reports have been shared with FAEA.

Recommendations

- 1. I recommend that FAEA considers support for the remaining steps, before policy and bill are presented in parliament, namely:
 - a. Publishing the draft bill and policy in the two local dailies with a national reach (this is a requirement)
 - b. National validation workshop
 - c. A final retreat to incorporate comments from the national validation and other comments that may have come between the completion of the 3rd taskforce meeting and the national validation day.
- 2. That the remaining activities are fast-tracked considering that next year is a general election year and many in government leadership may not have time to dedicate into the process.
- 3. That the national validation be held as a hybrid event to allow for the participation of those who may not be able to attend physically.
- 4. That the process of notification to the World Trade Organization (WTO), commences so that it does not became a point of delay.

Daily activity

Tuesday, 28 September, 2021

Wilfred Wachira, arrived early morning at Enashipai Resort to set up and ensure that all plans were in place, including a secretariat room for handling logistics, conference room and reservations. A technical team of about eighteen members also arrived on the same day. The technical team had to initially work on the approach to incorporate all comments coming from the field. One group that had not completed assessing all comments from the field was given time to do so. Further, the team worked on a matrix that aimed to organize all comments that



came through from various stakeholders into one reference document, in order to ease their consideration into the draft policy and bill documents. All similar comments from different stakeholders were clustered together. The members were also joined by the four rapporteurs who were involved in the County consultation exercises. The matric is referenced in Annex two and three.

Wednesday, 29 September 2021

The taskforce members continued to input comments into the matrix. On Wednesday, members largely focused on developing the matrix for the policy. This took the whole day due to the numerous comments from stakeholders.

Thursday, 30 September 2021

This session was chaired by Lucy Njenga. Members continued incorporation of comments in the policy matrix. A section of the members was separated in order to develop the joint matrix for the bill, in order to save on time.

Friday, 1 September 2021

There was a proposal at the end of the day to change the approach and have members working in groups, in order to speed up the incorporation process. Subsequently, members split themselves into three groups that handled the following areas:

Group one: comments from stakeholders consulted virtually and invited to send in their comments Group two: were to handle comments from the county processes

Group three: were to handle comments on the bill.

Saturday, 2 September 2021

The task force spent the better part of the day incorporating comments into the bill and policy, from the common matrix. Later in the afternoon, both the policy and bill were presented in plenary for concurrence. A way forward was also deliberated through guidance of the co-chairs. The meeting went past 8pm. Majority of the members departed on Sunday morning.
